

Tri State Swim Conference

“B” Championship Meet

July 31-August 1, 2010

- Location:** Claremore Super Recreation Center, 595 Veterans Parkway, Claremore, OK 74017, 918-341-4516. (Some map web pages find it at 595 S. Boling St.)
- Facility:** Six lane, 25 yard pool
- Times:** The meet will begin at 9:00 a.m. Warm ups will begin at 7:00 a.m. with times assigned by the Meet Director. The officials meeting will be at 8:30 a.m. The coaches meeting will be at 8:45 a.m. Lane timing and place judging will be assigned by the Meet Director in proportion to each team’s participation.
- Meet type:** Preliminary and Finals. The Finals will start 2 hours after the Preliminaries. The specific start time will be determined by the head official based on the timeline and the meet progress.
- Proof of Time:** All entry times must be proven by the submitting team via an html or Word version export of the Team Manager meet entry report with "include proof of times" option checked. To prove the relays, teams need to submit the relay designation, the actual relay time swam (not the one MM will build for you), and the meet that the relay received the qualifying time.
- Entry deadline:** Entries in the form of a HY-Tek entry file and a report of the entries with proof of time in the format specified above must be received by 11:00 p.m. on Tuesday, July 27, 2009. Entries and proof of time reports should be emailed to Charles Haverstick at cfhaverstick@yahoo.com NO LATE ENTRIES OR CHANGES will be accepted after the deadline to allow for validation of the entries.
- Entry Limit:** Each swimmer must have a qualifying “B” time for individual events and each relay must have swam an “B” time at an invitational or at a dual or time trial meeting the judging requirements established by the Tri State Swim Conference and being timely recorded with the Vice President of the conference. Each swimmer can swim a maximum of three (3) individual events and one (1) relay per day.
- Entry fees:** \$2.00 for each individual event
\$5.00 for each relay
\$5.00 entry fee for each swimmer

No deck entries are allowed.

Scratches should be submitted by 8:30 a.m. on both days.

Checks should be made payable to: The Claremore Swim Team.

Awards: Conference medals will be awarded for 1st -6th place in the finals for individual events.
Conference ribbons will be awarded for 7th and 8th place for individual events.
Relay event conference medals will be awarded for 1st -3rd place.
Relay event conference ribbons will be awarded for 4th -8th place.
Team trophies will be awarded for 1st – 3rd place.
Age group individual high point awards for both men and women will be awarded.
Best time and heat winner iron-ons will be given.

Heat Sheet: Heat sheets will be available to buy at the meet. A form for placing ads in the heat sheet, with instructions, is attached.

Rules: Tri State Swim Conference rules and rules adopted by the conference from USA swimming will be followed.

Officials: Officials will be appointed by the host team. Anyone willing to help officiate should contact the conference head official, Bob Cummins, and attend the officials meeting before the start of the meet.
